

The Scandal Surrounding The Crown Office



This may not have been the issue that has captured the major headlines in the last two weeks but it is significant and, yet again, shows the corruption that is at the heart of the Scottish Government.

The Crown Office admitted the prosecution against former Rangers Football Club administrators, Clark and Whitehouse, were malicious and conducted without probable cause. The pair were arrested and detained in November 2014 and were charged in relation to Craig Whyte's purchase of Rangers Football Club. The charges were dropped by the Crown Office in 2016. After the Lord Advocate investigated the prosecution, he concluded that it was carried out without a proper evidential basis and met the legal test for a malicious prosecution. (February 2021, link).

In a letter to the Justice Committee, the Lord Advocate wrote: "an agreement was reached with each pursuer that he would be paid a sum by way of damages of £10.5 million... In addition to these payments by way of damages, interim payments have been made to each of the pursuers in respect of legal expenses. In respect of Mr Whitehouse, that sum is £1,650,000.00 and in respect of Mr Clark, the figure is £1,436,250.00." These sums add up to a total of £24,086,250. Later he told Parliament that "with other cases pending, the cost to the public purse will increase and the ultimate cost is yet to be seen" (February 2021, link).

The Scottish Conservatives are insisting this matter is investigated by an independent judge and not one from the Scottish bench. It looks like the Scottish Government will agree to an independent inquiry but, as yet, ministers seem unwilling to speak about who will chair the inquiry.

As far as we are concerned, only a full, independent, judge-led inquiry can restore the public's confidence, in the justice system.

Supporting Local Newspapers



I was pleased to pay tribute to our local newspaper industry in a Scottish Conservative debate ten days ago when we demanded that the Scottish Government extends the period of business rates relief to local newspapers, many of which are already struggling to survive even without the additional burden of the pandemic. These newspapers have, on average, seen a cut of a third in their readership and a huge loss of advertising revenue because so many of their usual clients such as hotels, restaurants and holiday cottages are currently not operating and therefore not advertising their services. Our local newspapers are a crucial lifeline for both news and information, most especially for many older people who are not able to access news online, and they are an essential part of the democratic process in this country.

We do not understand why the SNP has failed to include them in business support - neither does the industry.



In The Local News

Readers know that I have been campaigning for many years to have an upgraded rail-link between Edinburgh and Perth. The current line has seen very little change in journey times for the last century and is significantly behind the efficiency of similar routes in other parts of the UK (which average only 35-40 mins for this journey length in comparison to 60-65 mins). It is inadequate for the increasing commuter belts around Milnathort and Kinross and north Fife and its upgrade is strongly supported by many businesses and the chambers of commerce.

The SNP however, seems set to cut £33m from the rail infrastructure part of the draft budget - something about which I questioned the Finance Secretary, Kate Forbes, at Finance Questions last week.





The Hate Crime Bill



This highly controversial bill will shortly be coming to stage 3 following lengthy amendments at stage 2 in which the Scottish Conservatives, including myself, have been heavily involved.

It is controversial because of some of the Orwellian moves to interfere in our lives (just as controversial in nature as the named person policy and that is saying something!) and because it has been so heavily opposed by the courts,the police, lawyers and the public at large. For example, the SNP a voted down a Scottish Conservative 'dwelling defence' amendment which would have protected people from prosecution for words said in your own home. Plus, the SNP has flatly refused to remove the stirring-up offences which threaten freedom of speech and a free press.

In other words, it will make it easier for you to be prosecuted for words said privately in your own home. For the characteristics of religion, age, disability, sexual orientation, transgender

identity and variations in sex characteristics the bill introduces stirring up of hatred offences. It is an offence to stir up hatred if behaviour is 'intended to' stir up hatred in a threatening or abusive way for these new offences. The Hate Crime Bill also offers no defence for speech uttered privately in your own home.

Genuine hate crime has to be punished but this bill goes too far.

Outdoor Education Centres

Readers will recall that, in the middle of last year, following the first wave of the pandemic, I worked with the outdoor education centres to secure emergency funding until April 2021. The Scottish Government provided £2m of the sector's "ask" of £3.2m but this is not nearly enough for financial viability in the future. It case, that around half our centres are perilously close to closure and therefore urgent action is still required. For the past few months I have been working with the leaders in the sector and with cyclist and adventurist, Marc Beaumont, to encourage others to donate money to a new trust fund which can provide additional funds. On 18th February, the sector launched its new document with the support of myself, Iain Gray (Labour), Liam McArthur (Liberal), Bruce Crawford (SNP) and Alison Johnstone (Green). We will continue to assist them in whatever way we can in order to preserve this

Climate Change Debate



Over the past month at the Environment Committee, Members have been scrutinising the Scottish Government's update climate change plan and, last Monday, held the Cabinet Secretary Roseanna Cunningham, to account over some key issues. These include those issues identified by the witnesses from whom we have taken evidence. Principally, they fall into the following 5 categories:

- 1. Given several key Scottish Government targets have not been met (eg landfill, recycling), what has been the main reason for failure?
- 2. Why have some industry sectors done very much better than others when it comes to moving towards net zero?
- 3. Why has there not been a more holistic approach to policy-making to ensure all sectors can work together with government(s) for example should there not be a much more joined up approach between forestry and agriculture?
- 4. What more can be done to encourage behavioural change?
- 5. What new skills are required to make green jobs sustainable for the future?

Salmond v. Sturgeon



At last. Alex Salmond should now appear under oath at the Holyrood Committee on Wednesday morning. This follows the prolonged wrangle about the publication of his evidence.

A previous version of the submission had been censored by SNP MSPs on the inquiry in case it breached court orders, privacy or data laws. That prompted Mr Salmond's lawyers to submit a revised version to put the matter "beyond doubt".

However, the Scottish Parliamentary Corporate Body (SPCB) agreed to publish the evidence with some redactions in place.

While this raises questions about the relationship of parliamentary committees to the SPCB, it means Alex Salmond's claims can now be included in the inquiry's final report.

As readers know, Mr Salmond alleges Ms Sturgeon repeatedly misled Holyrood about meetings he had with her in 2018 while he was being investigated by her officials over alleged sexual misconduct.

He claims his successor therefore breached the Scottish ministerial code - a resignation offence which she denies.


